**NOTICE OF INTENT TO ADOPT A CATEGORICAL EXEMPTION AND NOTICE OF PUBLIC HEARING FOR DESIGN REVIEW 20-7002 TO CONSIDER A PROPOSAL TO ALLOW FOR THE RECONSTRUCTION OF AN EXISTING COMMERCIAL SPACE, THE ADDITION OF PARKING AREAS, AND A NEW MEDICAL OFFICE BUILDING ON A 1.39-ACRE PARCEL. THE PROJECT IS LOCATED AT 300 SOUTH HIGHLAND SPRINGS AVENUE WITHIN THE SUN LAKES NORTH SPECIFIC PLAN IN THE GENERAL COMMERCIAL ZONING DISTRICT. (APN 419-140-041)**

**NOTICE IS HEREBY GIVEN** of a public hearing before the City of Banning Planning Commission, to be held on Wednesday, October 7, 2020, at 6:30 p.m. in the Council Chambers, City Hall, 99 East Ramsey Street, Banning, California, and by video conference call, to consider a Notice of Exemption (NOE) and Design Review (DR 20-7002) to allow for the reconstruction of an existing commercial space, the addition of parking areas, and a new medical office building located at 300 South Highland Springs Avenue within the Sun Lakes North Specific Plan, APN 419-140-041.
