NOTICE OF PUBLIC HEARING AND NOTICE OF EXEMPTION FOR CONSIDERATION OF DESIGN REVIEW 20-7007, CONCEPTUAL OPEN SPACE AND PARKS PLANS FOR PLANNING AREA'S 6/2B, 7/50B, 8A/8B, 24, AND 25 WITHIN TENTATIVE TRACT MAP'S 37390, 37390-1, 37390-2 (APN'S: PORTIONS OF 408-120-010, 012, 013 AND 020) FOR PHASE 1B OF THE BUTTERFIELD SPECIFIC PLAN

NOTICE IS HEREBY GIVEN of a public hearing before the City of Banning Parks and Recreation Commission, to be held Wednesday, March 17, 2021, at 6:00 p.m. in the Council Chambers, City Hall, 99 East Ramsey Street, Banning, California, to consider a Notice of Exemption and Design Review 20-7007 located in Phase 1B of the Butterfield Specific Plan. The Community Development Department has determined that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to section 15162 (Subsequent EIR's and Negative Declarations).

Pursuant Governor's Executive Order N-29-20 all public gatherings, regardless of venue or size, the Council Chambers shall occur with limited capacity and by videoconferencing. 










