**NOTICE OF PUBLIC HEARING AND NOTICE OF EXEMPTION FOR CONSIDERATION OF CONDITIONAL USE PERMIT (CUP) 23-0027, A PROPOSAL TO ALLOW FOR MEDICAL SPA OFFERING COSMETIC MEDICAL TREATMENTS AND THERAPIES WITHIN AN EXISTING IN-LINE SHOP LOCATED AT 3080 WEST RAMSEY STREET, WITHIN THE HIGHWAY SERVING COMMERCIAL ZONING DISTRICT (HSC)(APN 538-340-007).**

**NOTICE IS HEREBY GIVEN** of a public hearing before the City of Banning Planning Commission, to be held Wednesday, December 6, at 5:30 p.m. in the Council Chambers, City Hall, 99 East Ramsey Street, Banning, California, to consider Conditional Use Permit (CUP) 23-0027 to allow for a medical spa offering cosmetic medical treatments and therapies within an existing in-line shop located at 3080 West Ramsey Street in the Highway Serving Commercial zoning district (APN 538-340-007). The Community Development Department has determined that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 (Existing Facilities).

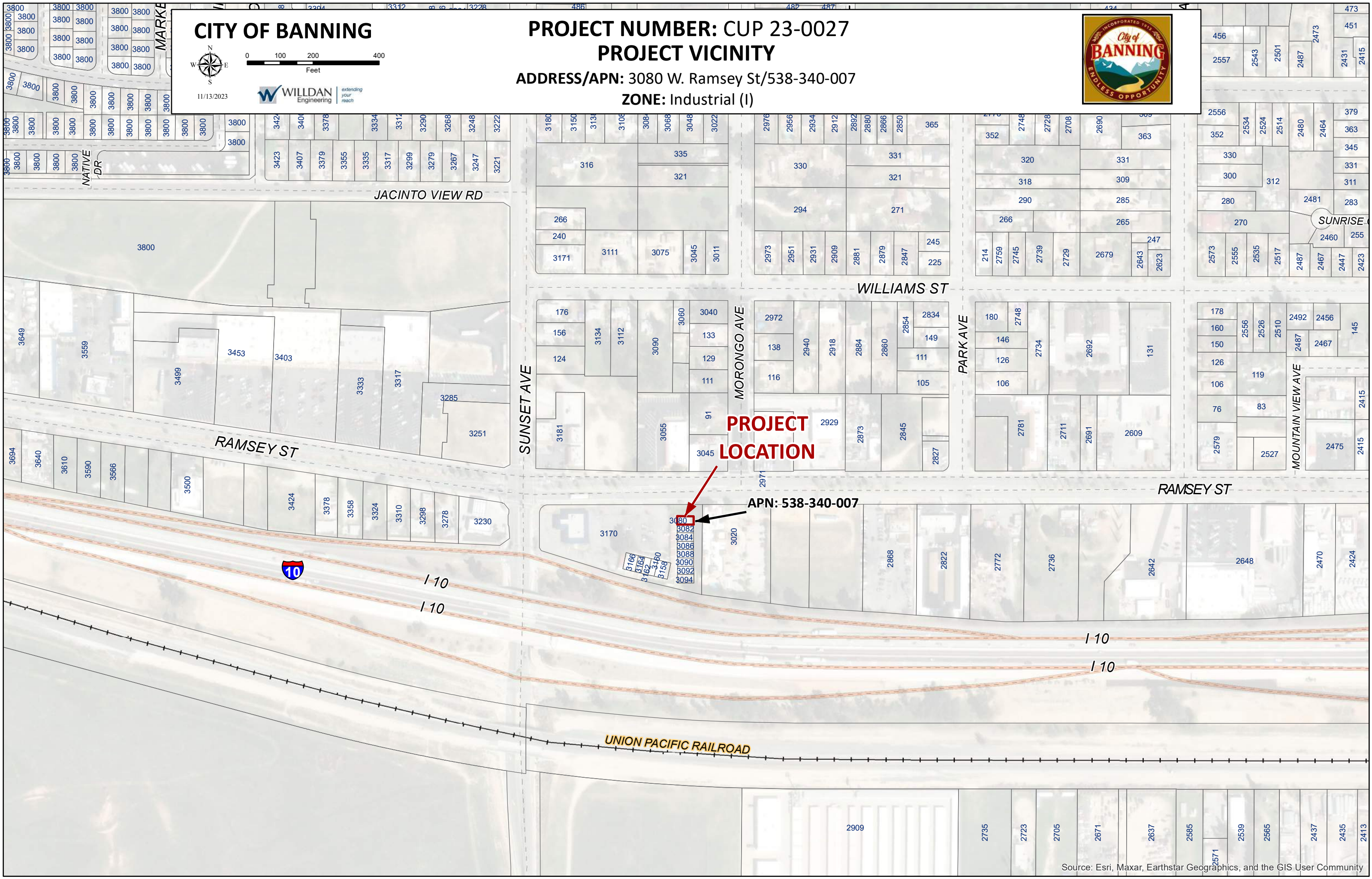
