NOTICE OF INTENT TO ADOPT A CATEGORICAL EXEMPTION AND NOTICE OF A PUBLIC HEARING FOR ZONE TEXT AMENDMENT (ZTA) NO. 17-97502 AMENDING VARIOUS SECTIONS OF THE ZONING ORDINANCE (TITLE 17 OF THE BANNING MUNICIPAL CODE) RELATIVE TO DEVELOPMENT STANDARDS AND NONCONFORMING USES AND LOTS AS WELL AS TO ADDRESS INCONSISTENCIES WITHIN THE TEXT

NOTICE IS HEREBY GIVEN of a public hearing before the City of Banning Planning Commission, to be held on Wednesday, August 2, 2017, at 6:30 p.m. in the Council Chambers, City Hall, 99 East Ramsey Street, Banning, California, to consider proposed Zone Text Amendment (ZTA) No. 17-97502 pursuant to Chapter 17.116 (Zoning Ordinance Amendments) of the City of Banning Municipal Code.

ZTA 17-97502 consists of amending Table 17.08.020 Permitted, Conditional, and Prohibited Residential Uses; amending Table 17.08.030 Residential Development Standards; amending 17.08.050 Accessory Structures; amending Section 17.08.110 Minimum dwelling size standards; amending Table 17.12.020 Permitted, Conditional and Prohibited Commercial and Industrial Uses; amending 17.32 Landscaping Standards; amending 17.36.110(B)(1) Sign Regulations, amending 17.68.140 Reconsideration; and amending Chapter 17.88 Non-conforming Structures and Non-conforming Uses.
