**NOTICE OF PUBLIC HEARING AND NOTICE OF EXEMPTION FOR CONSIDERATION OF ADOPTING A RESOLUTION UPDATING THE TRANSPORTATION UNIFORM MITIGATION FEE SCHEDULE FOR THE CITY OF BANNING. PURSUANT TO THE MITIGATION FEE ACT, (GOV. CODE § 66000 et. seq.) WRCOG PREPARED A NEW NEXUS STUDY TO UPDATE THE TUMF. THE CITY OF BANNING IS A PARTICIPATING JURISDICTION IN THE TUMF AND PROPOSES TO ACCEPT THE UPDATED FEE AMOUNTS, REFLECTING CHANGES TO THE TUMF NETWORK AND THE ASSOCIATED COST OF CONSTRUCTION.**

**NOTICE IS HEREBY GIVEN** of a public hearing before the City of Banning City Council, to be held Tuesday, October 26, 2021, at 5:00 p.m. in the Council Chambers, City Hall, 99 East Ramsey Street, Banning, California, to consider updates to the TUMF Program for the City of Banning. The City of Banning has determined that the adoption of this Resolution is not subject to the California Environmental Quality Act ("CEQA") pursuant to the State CEQA Guidelines Section 15060(c)(3), because it is not a project as defined by the CEQA Guidelines Section 15378. Adoption of this Resolution does not have the potential to result in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment. Further projects that are subject to this Resolution will require a discretionary permit, and CEQA review, which will be analyzed at the appropriate time in accordance with the CEQA Statutes and Guidelines.
